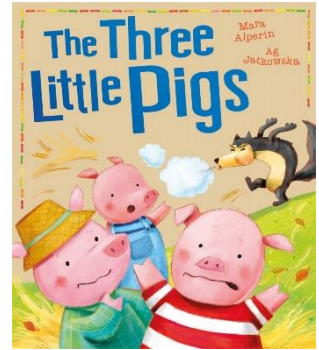

This week our topic has been Traditional Tales. We have been reading different versions of the story 'The three little pigs'.

Activities this week at pre-school:



- We read and acted out the original story of 'The three little pigs'.
- Making 'The big bad wolf' - The children cut out the face of the big bad wolf. They then decorated it using brown crayons, pens, tissue paper, card, eyes and teeth.
- Decorating a large brick house using red paint and rectangle shaped sponges. They also added real straw and sticks.
- Sensory/messy tray: The children played with cornflour mixed together with cocoa powder to make it brown. We added the three pigs from the story and some grass.
- Maths activity: The children had to match each pig to the correct brick house. Each house had a number of dots from 1-10, the children then matched the corresponding numeral.
- The children painted pictures with materials from the three little pigs story for example, sticks, straw bricks etc.
- Playing in the 'The Three Little Pigs Construction Site'. The children had high vis jackets, hard hats, foam bricks, real pipes, pretend screws and building tools.
- Building a house for 'The Three Little Pigs' on the playdough table. They had small building blocks for bricks, mini sticks and straw. The children used the playdough to stick the resources together when making a house.
- Different versions of lots of classic fairy tale books to read in the quiet area.
- We talked about why the 3<sup>RD</sup> little pig's house stayed up even when the wolf tried to blow it down. The children used paper straws to see which materials could be blown away by the big bad wolf and which materials wouldn't move.
- Tuff tray - The children tried to make houses with real sticks, straw and blocks.

### New Two year old funding

Dear Parents,

The new entitlements for eligible working parents with 2 year old children will start from April 2024. It is important that if you have a child who will be 2 years old before 31st March 2024 that you apply to HMRC (Childcare Service) in good time. It is your responsibility to check if you are entitled, make an application, and reconfirm every 3 months. Please set-up or visit your Gateway Account immediately to apply.

Please note that you may not be able to apply for the 2-year-old funding for working parents immediately if you have a Tax Free Childcare (TFC) account. We have been advised that you will be able to apply when you receive your TFC reconfirmation reminder.

If you have recently reconfirmed your TFC and not made an application, please ensure that you are due to reconfirm again in March before the deadline.

It is important that you allow time for any queries with new applications or reconfirmations to avoid delays. Any codes issued by HMRC in April 2024 will not be funded in Summer 2024. A code with an 'eligible from' date of 1st April 2024 will not be funded until Autumn 2024 and only then if you reconfirm by 31st August 2024.

The dates of your code are important, and you must reconfirm every 3 months to confirm eligibility and continue to access your funded childcare!

If you have a previous application for an older sibling, please check the eligibility dates of any new codes as the reconfirmation dates can be aligned to the previous child which could mean you need to reapply before the normal 3-month reconfirmation period.

If you have a code for an older sibling that needs to be reconfirmed, this should also be completed now, and if you are unsure, it is your responsibility to log into your Gateway Account and check. If you are newly eligible or are given a new code at reconfirmation, you need to take your 11-digit code to your provider who will complete a verification check and then confirm your funded space.

When eligibility ends, children can continue to access their entitlement in the Grace Period. However, new children, who are 2 or 3 before 31st March, or start at a new setting from April, cannot start to use this funding in the Grace Period if they are no longer eligible.

If the Grace period does not apply, or your Grace period ends, the entitlement will also end. If you continue to use childcare, you will be charged.

If you are making a new Gateway account with HMRC, you will be asked if you would like to register for Tax Free Childcare. If you do register, your Tax Credits may be stopped, and it can take several weeks to reapply and for Tax Credits to be reinstated.

If you have problems accessing the system or completing your check, please call the HMRC Helpdesk on 0300 1234 097 (your provider and Devon County Council cannot assist with new applications or reconfirmations).
